## **2 - WESTMINSTER - Justin Welby drinks the Kool Aid**

In early February, members of the Church of England Synod, met to discuss a motion put to them. The full text reads (from the <sup>1</sup>Church of England website)

*'That this Synod, recognising the commitment to learning and deep listening to God and to each other of the Living in Love and Faith process, and desiring with God's help to journey together while acknowledging the different deeply held convictions within the Church:*

*(a) lament and repent of the failure of the Church to be welcoming to LGBTQI+ people and the harm that LGBTQI+ people have experienced and continue to experience in the life of the Church;*

*(b) recommit to our shared witness to God's love for and acceptance of every person by continuing to embed the Pastoral Principles in our life together locally and nationally;*

*(c) commend the continued learning together enabled by the Living in Love and Faith process and resources in relation to identity, sexuality, relationships and marriage;*

*(d) welcome the decision of the House of Bishops to replace Issues in Human Sexuality with new pastoral guidance;*

*(e) welcome the response from the College of Bishops and look forward to the House of Bishops further refining, commending and issuing the Prayers of Love and Faith described in GS 2289 and its Annexes;*

*(f) invite the House of Bishops to monitor the Church's use of and response to the Prayers of Love and Faith, once they have been commended and published, and to report back to Synod in five years' time;*

*(g) endorse the decision of the College and House of Bishops not to propose any change to the doctrine of marriage, and their intention that the final version of the Prayers of*

***Bishops 36 for, 4 against, 2 abstained***


***Clergy 111 for, 85 against, 3 abstained***

### 3- LIVERPOOL - stop feeding our kids Kool Aid



A fifteen year old (white) schoolgirl, in school uniform is hassled/ sexually harassed by a male, who states he is twenty five years old. The interaction is recorded and posted onto social media. In the clip, the girl clearly tells the male that she is fifteen, and that what he is doing is not legal in this country.

It has not been confirmed, but it appears as though the male is possibly a migrant. The incident with the schoolgirl took place in Kirkby, which is two miles from a hotel used to house migrants.

A few days later a protest is staged outside the hotel and what appears to be a strategically placed and abandoned Police van is set on fire. The blame for this was placed on the protesters, leading to multiple arrests. Interestingly, videos later emerged on social media, which showed ANTIFA counter protesters actually setting fire to the police van.

Ongoing protests about the impact and cost of migrants are also happening in Dublin.

On Saturday 11th February, a few days after the incidents in Liverpool, GB News Journalist Charlie Peters released his documentary about grooming gangs, and the horrific abuse young (mainly white) girls have been subjected to. This issue has been, and continues to be, ignored by those who should protect them.

## **5- REMEMBERING GAVIN HOPLEY**

21 years ago, 19-year-old Gavin Hopley and two friends were out in Oldham town centre, after travelling the wrong way in search of a taxi home. They entered the area of Glodwick Via Waterloo street, which is an area generally known as a no-go zone.

It was at this point that they were spotted and then chased, in what was never going to be anything but a vicious attack on three white lads.

One of the lads was let into a local family's house to hide, another made his way back to Oldham town centre. Unfortunately, the third lad, Gavin, wasn't as lucky and was cornered by nine men. He was brutally beaten and with a final flying kick to the head, it bounced off a fence, before smashing down hard onto the concrete. Gavin died a couple of days later in hospital.

I have been tormented by a resounding thought going around in my head ever since that fateful night. I, myself, was out that very same night and got pulled by the police, who asked if I had seen anybody being chased? I responded by stating that, if he had gone this way, pointing towards Glodwick, "He won't be coming back". I then pointed in the opposite way and said if he has gone that way then "He is on his way home".

Then, a couple of days later, I read that Gavin had died. I have always felt terrible after I said what I did to the police. This incident happened the year after the Oldham Bradford riots. Tensions were still high in the town and the council were blaming the 'FAR RIGHT', when in reality, it was the council's own fault for not dealing with these issues, which is something I talk about a lot.

One man got rape and drug charges dropped, for shopping in another man who lied and said he wasn't there.

Nobody was ever convicted of Gavin's death, something which I heard many Pakistanis were actually bragging about around the town.

Gavin's family have said, 'They felt let down by the justice system'.

While Gavin lay bleeding on the ground, his assailants then robbed him. Although it does not say so in newspaper reports, I believe he would have been kicked or stamped on as well.

All of this adds to Oldham getting the Politically Correct stamp of approval. This is despite the way the council treats people - mainly white people, with absolute contempt, over any issue involving our Muslim communities in Oldham. This leads to resentment from other communities which the council then ignores and/or brands with PC words.

Unlike the Steven Lawrence case, Gavin's case has been completely ignored by almost everybody except people with a voice like mine.



### **8 - WHAT IS ABORTION? By Callum Leat**

Abortion is one of the most sensitive topics and is debated by millions of people in the United Kingdom. The political divide on this issue has never been wider, nor farther away from a conclusion or agreement. Pro-choice activists are mainly made up of left wing labour or democrats and followers of pink-pussy-hat-wearing third wave feminists. University and college students and many people in general believe that an abortion procedure is genuinely a woman's right.

Pro-life activists on the other hand, are mostly right wing conservatives or republicans and mainly followers of religious groups, most noticeably Jews and Christians who support traditional values such as marriage before fornication, and for babies inside mothers' wombs to have the right to life and not be murdered through abortion.

The question for the topic surrounding abortion is who is right and who is wrong, just like any two sides when it comes to a political discussion. The formal etymological definition of the word abortion, derives from Latin "abortiōnem" which today translates into English as the word for miscarriage. This means that the definition of this word has been changed over time to feed into people's own

selfish narratives into what an abortion means today. A miscarriage is not the same as an abortion, because when a woman has a miscarriage, it is not her choice and she has no control over whether the baby lives or dies. Compare this to the etymology of abortion today, where it now means a mother choosing freely to terminate the pregnancy by murdering her own baby.

The formal etymological definition for embryo, derives from the Latin word "embryonen" which in English translates into unborn living human. The earliest embryological multicellular stages occur in every animal on earth. The embryo stage lasts for eight weeks, after this it's called a foetus until its birth.

The word for "foetus" derives from the Latin word "fētus" meaning offspring in English, compared to the Greek language "φυτώ" which means to plant or sow a seed. It is mildly important for people in the 21st century, to realise that ancient Romans and Greeks understood the ethical importance of a single human life. Even in medieval Europe, they understood a baby was a human being at the point of conception even though they did not have our modern biological understanding.

## **The History of Abortion**

Marxist communists were the first ones with an ideological theory which included state provided abortion. It was a fundamental argument that abortion should be legally allowed in every case without the need for justification. On the 18th of November 1920, the Commissars of Justice and Public Health of the Russian Republic in the Soviet Union issued a Decree on Abortion, Vladimir Lenin signed this edict legalising abortion on every social ground as well as medical grounds. Thus the Russian Soviet Republic became the first government and nation in the whole world's history to fully legalise abortion.

To the Communists, who held beliefs stemming from Marxist theories, this was a step in the direction of a progressive and free liberal society, in which women had the right to terminate their pregnancies however and whenever they pleased.

Before the Soviet Union, the act of abortion was illegal in Tsarist Russia. Everything that was deemed offensive and condemned during Russian imperialism, was now condoned through the new red states in the USSR. It then infiltrated into conservative countries like the United Kingdom, United States and other major Western developed nations, which have now also fully legalised the use of ending a woman's pregnancy with medical intervention.

The idea for a state funded pregnancy termination would be implemented in future decades. Those Western nations, which were at first opposed to the radical idea of a state paying for a mother's child to be terminated, were now

being influenced by the same red state Marxist communist ideological philosophy, that it should be seen as morally right to murder the unborn.

In order to discover how the very first idea of abortion began in the West, we find that most of the instigators lived in the United States. When looking into those who founded Planned Parenthood in the healthcare system within the US, there are only three people that are worth mentioning, Fania Esiah Mindell, Ethel Higgins Byrne, and the most famous key figure of them all Margaret Higgins Sanger.

Let us address the issue with particular reference to Margaret Sanger, the life she lived, and her legacy. Her work involved creating what is known as the "Negro Project", a birth control program in the black community. Margaret Sanger was giving presentations on her project in front of the KKK (Klu Klux Klan). In 1926 in Silver Lake, New Jersey. Margaret Sanger spoke to multiple white hooded KKK members talking about her ideas of birth control, mostly to the women's auxiliary within the KKK. She spoke openly in favour of creating a superior white race by sterilising black people, who she considered to be a degenerate community.

She would later use her books and magazines, such as the "Woman and the New Race" and "Birth Control Review" which she had published through "TRUTH PUBLISHING CO." to brainwash the already delusional KKK racial hatred narrative onto the female members. Without a shadow of a doubt, Margaret Sanger was an extremist when it came to eugenics within politics, racially segregating the black family, specifically not wanting black people to become parents. Thus proposing the ideal framework of birth control so it would depopulate the American black communities which later affected the whole of humanity.

On the 27th of October 1967, a politician called David Steel received a royal assent to introduce a new legal act in England, Wales, Scotland and Northern Ireland. David Steel's private members bill was the introduction of the Abortion Act of 1967, backed by the British government, making it legal for a woman to have an abortion. The Abortion Act did not fully come into play in the UK until the 27th of April 1968, due to practitioners debating on what grounds two doctors should agree to implement an abortion. One suggestion was if the pregnancy would be a risk to the life of the mother during her labour, or if it would injure the mother's physical or mental health. On the 1st of November 1990, the Human Fertilisation and Embryology Act was established as the legal framework which the British government used to lower the gestation limit for abortions from 28 to 24 weeks.

24 weeks is today's limit for women within which they can terminate their pregnancies. This limit was the accepted point in time when the foetus was considered viable outside the mother's body. The act was later completed and

came into effect on the 1st of April 1991. In June 2017, with abortion now freely legal for any reason, the government of Northern Ireland introduced a scheme to fund abortions across the rest of the United Kingdom, mostly for mothers in Northern Ireland, Wales, Scotland and England. This provided free abortions for women in the UK, and also paid their travelling costs at the taxpayer's expense, with the British Supreme Court raising the case earlier in the same month.

The funding for the Northern Irish scheme was then provided by the Government Equalities Office and HM treasury in 2017. In the following year on the 28th of December 2018, two new abortion pills were made available to women in Wales and England for use in their own homes. These were Misoprostol and Mifepristone. Scotland had already introduced this the year before. This was to lower the costs to the health services by avoiding abortion procedures in British hospitals and clinics.

### **How Abortions Take Place in the UK**

With all the statistics and what we see and hear, I wonder what you think about the choices our women make and the world they wish to live in? As the Anglican Customary revealingly suggests, showing the dark truths about the murder of innocent British babies, killed in the name of "women's rights". Will you do anything to prevent the next innocent child having its soul taken away? Or will you still show support for the sorcerers who wish to end our lineages? If only Britain and the United States were shown the pain endured, blood spilled and the suffering of innocent babies with their heads being crushed inside their mothers' wombs. If we choose to continue down this road for legalising abortion, our streets will be running with the blood of the babies, with our own NHS still participating. "Planned Parenthood" is a subversive term, dealing with humans that they do not want to exist, murdering the baby and therefore the existence of parenthood. Let me plead with you, let me ask what does a life mean to you?

The following is how a British abortion procedure is processed in the United Kingdom. Our women are given an appointment to have a local check-up with a GP waiting in the cold hallway of a hospital ward. They are then taken into the abortionist's office and given information as to how the children will be ripped away from their physical bodies. These abortionists and doctors working in the fields of the NHS, show no regret in not telling their abortion clinic patients to think twice about their decision. The mothers make their final choice on terminating another human being. The women are taken into one of the spare back rooms within the clinic, placed onto the chair where the procedure is going to take place, and are then anaesthetised. This helps the woman to avoid looking at the abortion doctor's face while they kill her own baby, crushing the baby's organs, limb by limb. Sucking out the baby's body parts with a sucking machine, almost like a vacuum.

The controversy surrounding abortion in the UK is deeply bitter, British citizens can even be arrested for saying a simple prayer outside an abortion clinic. On the 22nd of December 2022, 45 year old Isabel Vaughan Spruce who is leading director for an anti-abortion group called March for Life UK, was arrested for praying outside an abortion clinic in the West Midlands and taken into custody for violating the Public Space Protection order. Police accused her of "protesting and engaging in an act that is intimidating to service users". The arrest for her devout, silent praying led to a righteous uproar on the internet.

## **UK Government Abortion Statistics**

Statistically, 209,917 abortions took place in the year 2020 alone, with 99% of the abortions in England and Wales being funded through taxation in the NHS in 2020 alone. The rates for women aged under 18 has decreased from 8.1 to 6.9 per 1,000 women between the years of 2019 and 2020. However the rate for women over the age of 35 has increased from 9.7 to 10.6 per 1,000 women. This data collected from the Department of Health & Social Care (DHSC) with public health services in the NHS, tells us that whilst younger women are having fewer abortions, elderly women are having more. 81% of abortions in 2020 were women who were not married, 51% of the abortions in 2020 were women who were not married although they were in a relationship. In 2020, 77% of women having an abortion were white, 9% Asian and 7% black, with 97% of women documenting their ethnicity. Meaning the majority of women having an abortion in the United Kingdom are native to the UK, along with a minority of women from other European countries. This is unlike the United States, where the majority of women receiving an abortion are African American, the minority population of America.

## **Why Children are a Blessing**

The right to life is one of the most important moral values any human must have. If vegans claim they condemn slaughtering cows, then they should surely forbid the slaughtering of our own human beings. Our little brothers and sisters which have been denied the precious gift of having experienced life.

## **Ways to Combat Abortion**

Feminists use the term independent to describe the ideal female state in womanhood, and this is a problem for logical debate. For a female to receive a child into her womb, she becomes responsible for the child whose human life has just begun. Therefore, pregnant females are no longer fully independent. New

waves of feminists also state that anyone, including men and trans men, can be pregnant. So anyone can have an abortion because they can no longer define what a woman is.

The Labour party and the LibDems cannot even defend little girls raped and abused by Pakistani grooming gangs. These girls' voices were silenced while the crimes were covered up for many years throughout the UK. This would seem like political suicidal madness. And using their logic that it's possible for a male to give birth, then why has no biological male ever done so throughout human history? Of course the left wingers use deception via media articles showing transgender men giving birth, who are in reality biological women identifying as men. 
## **12 - NOT IN THE BOX, AS BURNT IT TO KEEP WARM**

## **13 - NATO - North Atlantic Treaty Organisation**

Why is NATO a concern for you and me? - Why is NATO a concern for the NHPUK? And why is leaving NATO an important policy for the party? These are things that must be crystal clear.

First and foremost, you cannot have a nationalist vision and remain part of NATO.

In short NATO is part of the Globalist system that seeks a global power structure.. A One World centralised economic system propped up by One World governing institutions. That of course means the end of: the Nation State, control over borders and population, land, property, industry and war and peace.

On a deeper level, Globalism also means the loss of control of the people over the state, the family as the foundation of society and faith as the guiding light for people's lives.

So, was NATO always a Globalist project , was it always part of a 'One World' vision? That is not an easy question to answer and beyond the scope of this article.

Certainly, at the time of its founding it made sense. It was in fact not NATO, it was the North Atlantic Treaty. A treaty between nations for the common defence, which later became NATO when the 'Organisation' was set up.

Obviously NATO was set up with one thing in mind and that was defence from the Soviet Union after the Second World War. General Mac Arthur had wanted to

take the war to Russia once Germany had been defeated, but the politicians were not interested. That the Allies had made a deal with the Devil to defeat Hitler was clear. It was the UK that at first sought a common defence policy among European nations and created the Western Union. Later the U.S decided that a joint 'anti-communist alliance was in line with their foreign policy and the North Atlantic Treaty was signed.

Were invisible Globalist forces pulling strings at the foundation of NATO as there were at the foundation of the EU? That is a question I cannot answer. It is easy to look back from where we sit today and make a case for it. However, then was then and now is now. We know for a fact that it was the case with the EU, because it is written into the founding documents of the Coal and Steel Community, which is the founding organisation for the EU.

One thing that we have to realise – which is very much relevant to us now, is that the UK was at the heart of NATO right from the very beginning and still is today. The British establishment is deeply attached to NATO and that is the reason why we have been at the heart of keeping the war in Ukraine going.

If the North Atlantic Treaty genuinely started as an alliance of nations to protect their sovereignty from a big bad beast of an enemy or not, it has been sliding away from that original foundation.

What is very clear, is that the founding purpose of NATO no longer applied after 1991 and the collapse of the Soviet Union. The threat of the Communist superpower evaporated almost overnight. The collapse of the Soviet Union also saw the evaporation of the Warsaw Pact, the Soviet Union's counterbalance to NATO in the Eastern European nations left under its influence after the Second World War.

What emerged from the collapse of the Soviet Union was just one Super Power in the world:- The U.S.A - China was not an issue at the time. The U.S was the boss of the world, and those elements in the US with a Globalist vision of a 'New World

Order' saw their opportunity. A One World Government was now possible. By this time the Neocons had become influential in Washington, making peace with Russia as an equal partner was not on the agenda. Integrating Russia into the European economic and cultural sphere, was also not in the interests of the U.S, the Neocons and Globalists. By now, the West was being taken over by the Globalists in a big way. Traditional constitutionalism, Christianity, family values, had all been under attack since the sixties.

At the time of the collapse of the Soviet Union, there was the issue of East Berlin and East Germany to be dealt with. President Gorbachov, the architect of the fall of Communism was assured by western leaders that NATO would not expand beyond East Germany. Whilst verbal and written assurances were given, no treaty was made at the time.

Twice, Russia sought to even join NATO itself, and were rejected - Once under Yeltsin and once under Putin. Russia then and to this day, sought a common security framework.

In 1997 Russia and NATO established the NATO-RUSSIA COUNCIL and signed the FOUNDING ACT ON MUTUAL RELATIONS. This act was a commitment not to tread on each other's toes basically. However, if you read it you will find that there is no specific commitment by NATO not to expand. It is a kind of gentleman's agreement and that is how the Russians saw it. Russia was in no position to dictate terms. It is a victor's treaty in that sense.

Of course, the Russians were very much mistaken if they thought that NATO was going to hold back on expansion, as nation after nation of the old Warsaw Pact joined. They looked on in alarm as NATO expanded ever closer to their border on three fronts.

One thing that was made very clear by Russia, was that Ukraine joining NATO would be seen as an existential threat and it would be followed by military action.

Western leaders were fully aware of this, but chose to ignore it and Ukraine was added to the list of nations to join NATO in 2008.

The other issue was Ukraine joining the EU. Whilst Russia technically we're not opposed to it, they were not happy and tried to woo Ukraine with their own economic package. Of course, the issue being that becoming a member of the EU is almost an automatic pathway to NATO, or at least coming under its umbrella.

By now NATO has become the de facto military arm of the Globalist powers and Globalist interests. If there is any doubt about this, the war in Ukraine has exposed it beyond doubt. Statements by leaders of Globalist organisations have exposed that they fear that Russia is a threat to the globalist project and must be dealt with for that reason. Ukraine's sovereignty is not their overriding concern.

Why are Globalists so invested in Ukraine? There are probably more reasons than we will ever know. What we do know is that U.S global corporations like Monsanto are heavily invested in land and resources. The IMF bailed out the economy in 2014, so Ukraine has a large debt to global financial institutions. Lots of mineral resources and access to the Black Sea make it a prize for global corporations. U.S politicians have had financial interests and the U.S government was conducting biological research in labs across the country. The West is heavily invested and by extension seeks to bring Ukraine into the Globalist family via the EU.

What makes it galling for the Russians, is that NATO has been training and arming Ukraine since at least 2014. Whilst Ukraine is not officially a NATO country, it is a de facto member even if it is not under article 5, NATO is still able to project power up to the Russian border.

Whilst NATO started as a defensive alliance, somewhere along the line that changed. What didn't change is that Russia is the main focus of its intent.

However, as the military arm of Globalism, NATO's remit is now growing beyond Russia. It now has what it calls 'Partners Across The Globe' – These are individual relations with so far, nine nations that it calls: 'Global Partners of importance, in a complex security environment'

NATO is also looking at its relations in the Pacific region, as it considers how it is going to deal with the expanding power of China. In other words, our government is now part of a Globalist partnership that protects the interests of the Globalist power brokers. Of course, that doesn't mean that our nation's interests are not always served, but the question is, what is the ultimate purpose? Is it the borders of our nation and the lives of our people at the heart of our defence policy or something else.

Throughout history nations and groups of nations have made alliances for common defence. There is nothing wrong with that. However, they have not invested their power in a supranational military organisation to uphold them.

When nations become part of supranational governance structures such as the EU, UN, WHO, WEF etc, then an organisation like NATO will automatically become an extension of those institutions.

That is why NATO can never be part of a vision for the restoration of National sovereignty.

For most of us, it has been in existence our whole lives and the world without it is not easy to conceive.

Britain has been so weakened by the globalist, socialist, communist project that we can hardly stand on our own feet. Militarily, we can barely defend our own land any more. Our military is designed to support the globalist agenda not defence of the realm.

Britain throughout its history has been a nation able to produce and have surplus, which is why the Romans invested in it for 400 years and why the battle for

control of the land was so fierce in the years after they left. Once a unified land, it became a strong nation in all ways including militarily.

Leaving Globalist organisations and treaties that do not have the interests of our people at heart is of the highest priority.

That is why the NHPUK policy to leave NATO is not a side issue in its policy platform, It is central and urgent. It

Many news reports on the day were overly biased towards Standing for Women.


Lastly, the Picture of me is with Shazia Hobbs, a women's rights campaigner who I met up with a few years ago. She is a great lady and very well respected by myself.

## **16 - From A Camp In France To His Own Home In The UK Within A Month - THE STEVE LAWS REPORT**

An illegal immigrant has shared videos on TikTok showing his journey from a camp in France to his very own home in the UK.

In the first video, he is showing himself in a camp in Northern France, which seems to be in the Dunkirk area. From there, he then shows himself in a dinghy heading towards the UK, before being picked up by the Border Force and ferried back to the UK.

A month later, the same man uploaded another video on his TikTok showing that he has now been given his very own home. That's right, he was in a French camp just a month before being given a home at the taxpayers' expense.

Of course, we've all known that illegal immigrants were being given their own homes, it's just a shock to see it happening in such a short time scale. Some councils are even building homes specifically for so-called 'refugees'. So whilst you and I struggle to pay our bills, invaders are having homes built for them.

This will be a common occurrence throughout 2023 with the Home Office desperate to get the ever-growing hotel numbers down. The cost currently stands at over £7 million per day.

Serco, along with Clearsprings Ready Homes and Mears, have been offering lucrative incentives for landlords to choose to house illegals and refugees, instead of the people already living here who desperately need homes.

The incentives include but are not limited to are;

- Leases which are available for 5+ years with no void periods. Rent is to be paid in full, on time every month, with no arrears.
- Full repair and maintenance lease excluding latent and structural defects.
- Utilities and Council Tax bills paid.

- Full HMO and property management including monthly property and periodic safety inspections.
- No letting or management costs.

For more information on these letting benefits, please read an article we wrote on it a while back.

Whilst many Brits are struggling to pay bills, afford their rent or even afford to live, the government seems to have a blank cheque when it comes to housing immigrants. Of course, let's not forget, it's ultimately our money, taxpayers' money, being squandered on this open border vanity project.
